# A REPORT ON THE PRESIDENT'S WHITE PAPER

At the Board of Directors' meeting held in Los Angeles on October 24th, President Walter H. Walters delivered a White Paper in which he summarized five months' observation of the Institute as its chief executive. The following is the Newsletter editor's interpretation of that document.

After expressing the hope that both current and prospective members would support the Institute's current leadership in its attempted redefinition and strengthening of the Institute's shape, its goals, and its services, President Walters addressed himself to specifics:

ADMINISTRATIVE STRUCTURE: As chairman of an ad hoc committee on structure in Dallas, President Walters initially proposed that the Institute's administrative structure be greatly streamlined. Instead, however, in deference to the popular feeling that the administrative body should be concerned both with business and with information aspects of the Institute, an Executive Council was created composed of elected and appointed heads of committees, officers, etc., to both administrate and exchange information.

As a compromise, the Executive Council has served neither purpose to best advantage: as an administrative body, it is hampered by its size; as an informational body, it is impaired in providing information directly to the membership at large, where it is needed.

MEMBERSHIP: Careful thought should be given to the question of the type and the size of the Institute's membership. The Institute will need to closely scrutinize the aims and goals for which it was originally founded.

NATIONAL-REGIONAL RELATIONSHIP: The Institute should acknowledge, encourage, and accomodate the regional sections, which have successfully moved it from local, albeit strong origins, to a stage of national prominence.

<u>CONCLUSIONS</u>: The outgrowth of these considerations should be a stronger focus on the service, publication, information exchange, and research activities of the Institute, with an eye towards serving the interests and needs of a more active constituency. Hopefully, these considerations will be high on our list of priorities as we move forward at the annual conference in San Francisco in March.

# A CORRECTION RE: PIN PLUGS

THE PIN PLUG IS ALIVE AND WELL

In the September/October Newsletter it was reported that the "Occupational Safety Act of 1971" required the use of twist-lock or "U" ground connectors on Stage and television lighting equipment. THIS INFORMATION WAS IN ERROR.

To begin with, the pin connector is still an acceptable connector and if you use this type of device, there is <u>no need</u> to <u>change</u>. The "Occupational Safety Act" does state that a new UL approved twist-lock configuration is to be used on all new equipment where codes require that the fixtures be grounded. This new configuration is referred to as NEMA Configuration L5-20 in the common 20 amp 2 wire plus ground. This type of connector is not interchangable with the old 3 wire 20 amp twist-lock. Manufacturers of stage lighting equipment are now supplying the new configuration on twist-lock specified applications unless advised otherwise. You can identify the new configuration by the ear on the "ground" pin turning inward. The old style (7300 series) has the ear turning out.

If your facility uses the old configuration, you do not have to change over unless advised so by your local code authority. The old style remains available for use in existing installations, although it is not UL approved. Nor do you have to change from pin connector to twist-lock. Pin connectors are still available from Altman Stage Lighting, Kliegl Borthers, and Union Connector Co., among others.

The article in question only listed one manufacturer of the new twist-lock connector. In addition to the Harvey Hubbell Co. (series 2300), this new configuration is available from Bryant Electric (series 7052) and from Pass & Seymour (series L520). Other manufacturers that will possibly have connectors in the near future are Arrow-Hart, General Electric, Leviton, Circle F, and Rodale Electric.

ANNUAL USITT CONFERENCE, MARCH 26-29, IN SAN FRANCISCO.

In addition, there will be competitions in Costume Design and Scene Design, which are reported on in greater detail in this Newsletter.

# **DESIGN COMPETITION**

USITT is sponsoring two design competitions to be held in conjunction with the 1972 USITT Conference in San Francisco: a Scene Design Competition and a Costume Design Competition.

Within each Competition, there are three categories, each offering three cash prizes (First Prize: \$75.00; Second Prize: \$50.00; Third Prize: \$25.00 -- Total cash prizes: \$900.00).

The categories are as follows:

<u>UNDERGRADUATE</u> -- Open to all undergraduate students currently enrolled in a college. Entry blank <u>must</u> be signed by faculty sponsor.

<u>GRADUATE</u> -- Open to all students currently enrolled in a graduate degree program. Entry blank <u>must</u> be signed by faculty sponsor.

OPEN -- For all entries not encompassed by the above two categories. In addition, all undergraduate and graduate entries will also be judged in the Open Competition.

#### BASIC RULES;

1) Individuals may submit entries for

both the Scene Design Competition and the Costume Design Competition. Use a separate form for each.

2) Each entry is limited to not more than three sketches or photos. Each entry is limited to one play. In the case of a double entry (scenic and costume), separate plays may be selected, but need not be.

3) Sketches and photos should be matted, labeled on the back as to play, act, and scene or character, as well as the name and return address of the designer. Scene design entries should include a small ground plan on the back as well. Models will not be accepted as entries. Color photographs of models are acceptable. (No slides, Please.)

4) Entries must be carefully packaged. USITT will not be responsible for damage incurred enroute to and from the Conference.

5) Announcement of awards will be made on March 26, 1972. Prizes and lists of competition winners will be mailed to those not in attendance at the Conference within 30 days after the close of the Conference.

6) All entries will be returned  $\underline{COL}$ -<u>LECT</u> immediately after the close of the Conference.

7) The exhibition will consist of the winning entries, honorable mentions if such are designated by the juries, and other entries deemed worthy of display. The decision of the juries will be final.

Although information, including official entry blanks and rules, will be mailed out with regard to the competitions, the following facsimile entry blank in a photographically reduced from is provided in case there is a shortage of official entry blanks. Typed and executed forms following this format will be accepted in lieu of the official form.

# 1973 CONFERENCE SITE OPEN FOR BID

The TIME AND PLACE COMMITTEE is receiving bids for the 1973 and 1974 National USITT Conferences. The selection of both sites will be announced at the 1972 Conference in San Francisco.

Bids should be forwarded to the Second Vice President, USITT, 245 West 42d Street, New York, N.Y. 10019.

Bids should specify a sponsoring group within USITT. This does not need to be an existing section, nor even a nascent section. It should, however, consist of a group of persons willing to committ themselves in advance to undertaking the very large task of putting on the Conferences. The size of the sponsoring group, in the absence of a formal USITT regional section, should consist of not less than 10 persons, not all of whom need to be USITT members at this time. At least five of the minimum ten must be USITT members.

Bids should spell out in as much detail as possible the potential advantages of choosing the particular site, potential hotels to be used as Conference Headquarters, activities planned, etc. Bids for the 1973 Conference should be

Bids for the 1973 Conference should be received at the national office of USITT not later than February 1, 1972. Bids for the 1974 Conference should be received not later than March 1, 1972.

# **GROUP FLIGHT PLANS**

# **OISTT SECOND CONGRESS**

The Second Congress of the OISTT took place in Prague, Czechoslovakia from June 7 -12, 1971, with a total attendance of 227 individuals (20 Americans), representing over thirty countries.

Papers were delivered on two major themes:

 Theatre in Multipurpose Buildings.
New Expressions of Theatre Forms and Scenography.

Meetings held included the following OISTT Committees: Scenography, Architecture, Publications, Engineering, Education, Program, and Executive. Three new member countries were admit-

Three new member countries were admitted, bringing the total to 17. By June, 1973, the OISTT expects to number 21 countries.

Elected to a two-year term as President of the Executive Committee was JOEL RUBIN.

In conjunction with the Congress, a book and periodical exhibit was held. The Prague Quadrienielle II, International Exhibition of Scenography and Theatre Architecture, was participated in by 30 nations, although particularly and noticeably absent were Great Britain and the United States.

#### ON MIROSLAV KOURIL 60th

Ing. Arch. Miroslav Kouril is Director of the important and unique center for the development of scenography and theatre technique, the Institute for Scenography in Prague.

After gaining his first experience in this field as stage manager in E.F. Burian's well-known avant-garde theatre in the early 1930s, he joined its leaders (Burian, Novotny, and Raban) in planning a vanguard studio as a laboratory of all art forms and school of modern culture. Lack of funds caused the project to fail, but the authors' stage experiments demonstrated their earnestness.

Later, Mr. Kouril, together with Professor J. Murakovsky and producer J. Honzl, laid the foundations for theoretical studies of scenography. According to Mr. Kouril, scenography is "a science of creation and realization of scenic production and of the preparation of environment for the composition and perception of staging." For him, scenography is a complex knowledge of stage technique and technology, as well as of the construction of theatre space, all of which bring to life the artistic project of the stage designer -- the scenery.

Mr. Kouril's writings include a series of studies treating different problems of scenography, published in the Czeck periodical Acta Scaenographica and the international <u>Interscaena</u>, a book, "On the Little Stage," (Prague, 1955), and a forthcoming comprehensive study in six volumes, "Bases of Theoretic Scenography," the first of which, "Introductory Reflections," was published in Prague in 1970. As editor he gave impulse to the big, lexicographic descriptive dictionary, "Scenography"), which promises to become a unique review of all aspects of scenography.

# **MIDWEST SECTION**

TOUR OF THE ARIE CROWN THEATRE

The December 4th program and tour of McCormick Place's Arie Crown Theatre was attended by 85 persons. The program was arranged by the Midwest Section's Architecture Committee Chairman Bernhard Works and Section Treasurer George Patterson.

Charles J. Palutis, Jr., Architect, of C.F. Murphy & Associates, spoke on the physical attributes of the theatre and the dominant factors in planning the rebuilding after the fire of 1967 -- a need to utilize as much of the remaining structure as possible within the framework of a new superstructure. He emphasized that the primary role of the architect had been to coordinate to practical and the aesthetic elements. Theatre consultant John Dittamore of Purdue University, who had also been the consultant for the original Arie Crown, elaborated on equipment installed in the new theatre and on the emphasis placed on making it more flexible than that previously used, so that the theatre would be a fully-equipped, versatile rental space.

Ross Major of Major, Inc., spoke on his role as supplier of stage lighting equipment designed to meet the consultant's specifications.

The acoustical consultant, Bolt, Beranek & Newman, was represented by Larry Kirkegaard. He explained the solutions adopted for the various problems the firm encountered in the fields of sound isolation, mechanical noise control, and room acoustics.

William Taylor, Director of Theatrical Services for McCormick Place, evaluated the theatre and noted problems encountered in the use of the new facilities. Of particular interest was the emergence, due to the increased popularity of rock shows, of a new, younger audience than that which generally frequented the previous theatre. Mr. Taylor suggested that a less traditional, less elaborate, more easily maintained decor might be better suited for accomodating the new audience.

The speakers and Tim Loomis of Major, Inc., George Petterson and Max Roller of Art Drapery Studios, and Tom Ryan and Harry Warner of the Arie Crown crew were available in various areas of the theatre to demonstrate equipment and answer questions as the members informally toured the theatre.

Midwest Section Chairman James Campbell took the occasion of Tom DeGaetani's attendance to set up two informal informational sessions: the first found Mr. De-Gaetani meeting with 18 activist members of the Midwest Section's developing high-school division, and, following the tour, a luncheon attended by 16 Midwest members in which the Executive Director reported on Chicago and New York Sections, outlined in greater detail elsewhere in this NEWSLETTER.

Contingent on outside funds to permit acquisition of staff and resources for data analysis and compilation, USITT hopes to publish a compendium of all data received since 1964 during 1972.

STUDENT THEATRE DESIGN PROBLEM As previously announced, USITT wishes to implement the Student Theatre Design Problem nationally during 1972 on the basis of the USITT prototype project at Pratt Institute (see USITT JOURNAL #9, May '67). Further to this, the National Office recently received the following:

"The American Institute of Architects endorses the concept and format of the Student Theatre Design Problem sponsored by the U.S. Institute for Theatre Technology./We believe that this unique problem represents a welcome departure from the concept of the traditional student competition which tends to interfere with rather than support the ongoing educational processes and objectives of the schools./The USITT problem is offered to the architectural schools in an effective teching and learning format and carries with it consultants and resources necessary to achieve excellent results./We hope the architectural schools will take advantage of the Student Theatre Design Problem." # THEATRE IN THERAPY IN THEATRE

On Saturday, December 4th, from 12 noon to 4 PM in the Normandy Room at 11 East 7th Street, an activity entitled THEATRE IN THER-APY IN THEATRE was held which lasted, due to the enthusiasm of the participants and spectators, for considerably longer than the time originally scheduled.

The event, coordinated by Priscilla Hartke on behalf of USITT's New York Area Section's Committee on Performing Arts Training and Education, was attended by more than 35 persons, including Professor Gasper from Queens College with a group of students. The session was taped.

The session featured a demonstration of improvisation in character development for a production, a demonstration of theatre "games" to develop spontaneity, and a group discussion of the development of actors to a point where they can overtly relate to others.

Hanna Weiner, of the John Jay School of Justice, City University, and Experimental Training Associates, discussed the background of psychodrama and its uses in the development of spontaneity in film and plays. This was followed by the group's participation in a psychodrama session.

Barrie Stavis, playwright, said of the event: "It opened avenues for the development of material. Of particular interest in the demonstrations was the illustrated possibility of players projecting multiple perspectives on the same stage at the same moment -- lending dimension to the situation being played. The program was handled with enormous imagination and breadth, and the diversity of the audience and their enormous involvement prompted the extension of the session."

Hazel Byant, Artistic Director of the Afro-American Total Theatre, found "the participation of immediate use for the current production on Attica; the response of the audience was testimony to the effectiveness of the session."
