Women In Design International Competition Deadline

Women in Design International announces its second International Design Competition. The competition is open to all fields of design, and there are 18 categories in which a designer may enter; including Architecture, Ceramics, Fashion Design, Fibre Art, Theatrical Design, Photography, Graphic Design, Landscape Design, etc. Entries do not have to be designed specifically for this competition, nor should they represent simply one piece of work.

The winners of the 1982 competition will have the opportunity for their works to be part of a travelling exhibit, as well as being represented in the Second Annual Compendium. The first Women in Design

International Competition (1981) drew entries from fourteen countries and from forty of the United States. The resulting compendium contained the work of 160 women; the preparation of this book was funded in part by a grant from the National Endowment for the Arts Design Arts Program.

All entries must be submitted on 35mm professional quality slides with a maximum of 10 slides. Do not send any original art. Entry fees are \$25 for 5 slides in one category or \$40 for 10 slides in one category. **ENTRIES MUST BE POSTMARKED BY FEBRUARY 15, 1983** accompanied by full remittance.

National Arts Jobbank

The Western States Arts Foundation announces a subscription rate increase for *The National Arts Jobbank* effective January 1, 1983. Jobbank subscription rates are *currently* a mere \$15 for a six-month subscription of 12 issues and \$27 for a year's subscription of 24 issues. Due to increased costs of publication and postage, rates will be \$18 for a six-month subscription of 12 issues and \$32 for a one-year subscription of 24 issues. *Subscriptions will be accepted at the low rates of \$15 and \$27 before January 1, 1983.*

The National Arts Jobbank provides a central source of current job openings in the visual and performing arts, arts education, arts marketing and general arts administration. Employers listing with the service include universities, state and local arts agencies, national service organizations, art centers, museums, symphonies, and theatre, dance and opera companies. The typical listing describes a position's responsibilities, qualifications, salary level, deadline and application procedure.

Taxes And You

There have been several tax law changes regarding office space, second incomes and educational expenses. Check with an accountant, the local IRS office or a good regulation book. It is now possible to get home office credit for second jobs more easily. However, keep very accurate records to prove that: one, you use the office or shop space exclusively (or prorated) for your business; two, that you are using it as a professional source of income. The latter especially applies to those who are designers or who make a craft or arts product. IRS is very leery of what they consider the weekend amateur. Keep good records. There are several good books available at most office supply stores (and their cost is deductible). It's equally possible now to deduct expenses of a business that is not related to what you normally do as long as you prove that it is intended as a business.

The Annual Conference and other educational seminars that you attend for the purpose of keeping your current job are generally considered tax deductible. Keep accurate records — including, if applicable, a letter from your employer indicating the above.

FEDAPT Announces Theatre/Dance Middle Management Program

The Foundation for the Extension and Development of the American Professional Theatre (FEDAPT) will conduct the seventh year of the Middle Management Program for managers working in not-for-profit professional theatre and dance companies. The Theatre/Dance Middle Management Program is held at the Eugene O'Neill Memorial Theater Center in Waterford, Connecticut, and presents three non-consecutive, intensive one-week workshops devoted to the in-depth investigation of management issues affecting the arts. This program is available to approximately 15 middle managers or managing directors that work directly with the issues to be discussed. Each participant must be nominated for each individual week from their respective professional theatre or dance company and selected through a review process.

Jessica L. Andrews, Theatre Program Director and Nello McDaniel, Dance Program Director of FEDAPT will administer the program. Each week will have a Co-Director and working professionals as seminar leaders.

University of Texas At Austin Acquires Gloria Swanson Archive

AUSTIN, Texas (Spl.) — Calling it "our last chance to get the greatest silent film archive," Decherd Turner, director of the Humanities Research Center at the University of Texas, has announced the acquisition of a 100,000-item collection from the film star Gloria Swanson.

Negotiations with Miss Swanson, now in her 80's and living in an apartment on Fifth Avenue in New York City, began in May 1982, and concluded Nov. 17 with the delivery of 78 boxes and four file cabinets full of materials to the Harry Ransom Center.

Contents of the collection cover the years from 1913 to the present and include handwritten notes for Miss Swanson's autobiography "Swanson on Swanson" (published in 1980), scripts and publicity photos related to her many films, and correspondence with Mary Pickford, William Faulkner and other famous persons.

Also included in the Swanson archive is a letter from 12-year-old John Kennedy, thanking the screen star for a gift. In her autobiography, Miss Swanson revealed a three-year romance with John Kennedy's father, Joseph P. Kennedy, who served as her business manager for a time. Correspondence with the Kennedys and certain other items in the collection will remain sealed until 2000, Mr. Turner noted.

Among the stars of the silent screen era, he said, "Swanson was IT."

The Hoblitzelle Theater Arts Library on the seventh floor of the Harry Ransom Center will house the Swanson archive. The collection will fill what Mr. Turner describes as a blank space in the history of films of the silent era. Heretofore, that period was represented in the HRC collections primarily by visuals such as movie posters.

The Swanson material adds publicity photos; film, theater and radio scripts; videotapes and cassette recordings; scrapbooks, diaries and business records; professional and personal correspondence; press clips, fan mail and three-dimensional works, as well as paintings by Miss Swanson and paintings of her by friends.

Born in Chicago in 1899, the actress began her career at the Essanay Company studios in Chicago in 1914. That same year, she met and worked with Charlie Chaplin.

Miss Swanson later appeared in more than 20 films for Paramount studios, including "Beyond the Rocks" with Rudolph Valentino, "Manhandled," "Zaza," "A Society Scandal," "Madame Sans-Gene" and "Fine Manners." Her own productions included "Queen Kelly" and "Sadie Thompson."

She received three Academy Award nominations — for her performances in "Sadie Thompson" (1927), "The Trespasser" (1929) and "Sunset Boulevard" (1950).

Students interested in obtaining the latest information concerning internships need only contact the national office of the U.S. Institute for Theatre Technology, 330 West 42nd Street, Suite 1702, New York, New York 10036.

An individualized computer print-out containing detailed information about the experiences offered by a theatre or a firm will be sent directly to the person requesting it. Internship opportunities are available in the following areas: Administration (Box Office, Business Management, Public Relations, etc.), Design (Scenery, Costume and Lighting), Technical Production, Costume Technology, Management (Stage Management and Production Assistance), and Manufacturing and Sales. Each request must indicate which area is desired and be accompanied by a \$3.00 handling fee for each area requested. The list contains names of theatres and firms which accept as interns bonafide students enrolled in an academic program of study; this is **not** a job placement service.

The work sites are asked to keep their entries up-to-date so that information supplied to students is as current as possible. Over one hundred twenty different organizations are represented in the present listings. This on-going service of the USITT is the result of over two years of work by a committee chaired by Harvey Sweet, of the University of Northern Iowa, and Don Stowell, Jr., of Florida State University, where the computer operation is coordinated by Jack Miller.

New Information Guide To American Actors & Actresses

American Actors and Actresses: A Guide to Information Sources (Gale/about 660pp./\$42.00) lists and describes the major published sources of information on American actresses and actors. Included in the information guide are some 250 individuals who were associated primarily with the legitimate stage, from its eighteenth-century roots to the present time. While most of the actors and actresses covered in the guide were born in America, a number of eighteenth-century English performers who forged a theatrical tradition in America are included. Also covered are stars of foreign birth who had substantial and influential careers in the United States.

American Actors and Actresses is arranged in two major parts. In the first part, annotated bibliographic entries are furnished for a wide range of general

information sources on American actors and actresses, including general references, dictionaries, encyclopedias, and biographical guides; biographies and indexes; general and specialized histories, surveys, and regional studies; books and serials; biographies and autobiographies.

The second and largest part of the guide is devoted to individual performers. Also covered in this part of *American Actors and Actresses* are notable acting families, such as the Barrymores and the Booths, along with individual family members. For each individual performer, the guide furnishes annotated bibliographic listings for books and articles about the performer. Citations are limited to major published sources in English and do not include, as a rule, dissertations, newspaper articles and obituaries, reviews of specific performances, or collections of personal papers.

Completing *American Actors and Actresses* are comprehensive Author, Title, and Subject Indexes.
