The 29th USITT National Conference and Stage Expo will be held at the Disneyland Hotel, Southern California's largest hotel March 23 through the 26th, 1988.

The theme for the Anaheim Conference is THE WIDE WORLD OF PERFORMING ARTS. Because Southern California is a major entertainment capital of the world, the Anaheim conference committee has chosen to expand the normal coverage to include more television, film, theme parks and other large entertainment industry points of interest. This concept reflects the fact that these parts of the entertainment industry are particularly vital to the economic health of the region. Theatre is the cornerstone of most USITT activities and will also be well represented at this conference.

There are several key innovations planned for Anaheim '88. One is the introduction of the "blockbuster" program event. "A good example of the blockbuster concept," according to Joe Tawil, program chairman, "will be to have a tour to Universal Studios, the world's largest television and film studio. There we will have access to backstage opportunities including costumes, set design, lighting and sound. So there should be something of interest for everyone."

Architecture: Brooklyn Museum Announces Exhibition

A New Brooklyn Museum: The Master Plan Competition, an exhibition documenting the recent architectural competition held by The Brooklyn Museum to develop a master plan to complete its unfinished Beaux-Arts building by McKim, Mead & White and to guide its future into the next century, will open December 18 and be on view through March 7, 1988. It will include 60 architectural boards and five models submitted by the finalists in the competition: Atkin, Voith and Associates with Rothzeid Kaiserman Thompson & Bee; Kohn Pederson Fox; Skidmore, Owings and Merrill in association with Vitetta Group/Studio Four; Voorsanger and Mills Associates; and the winner, Arata Isozaki & Associates/James Stewart Polsheck and Partners. Supplementary materials will focus on McKim, Mead & White's original design and place the Museum and the competition in a historical context.

The exhibition will be accompanied by a book on the competition which is being co-published by The Brooklyn Museum and Rizzoli International. It will also reproduce each architectural board in full, many in color, and provide a full treatment of the competition, with a synopsis of the program guidelines provided to the architects and design statements that show how each of the five finalists tried to meet those criteria.

Health & Safety: Stage Rigging Workshop

The University of Illinois, Department of Theatre, Division of Design, Technology, and Management, in conjunction with the USITT Health and Safety Commission is tentatively planning to offer a Stage Rigging Workshop in June of 1988. This is conditional on the number of responses received by September 30, 1987.

The purpose of the workshop is to offer an intensive, advanced course in stage rigging for professional people in the Entertainment industry. A Certificate will be awarded following the successful completion of the course. The course will be offered on nine continuous days beginning on a Saturday and ending on the second Sunday. The classes will run all day and possibly some evenings. They will consist of lectures, discussions, hands on laboratory sessions, and demonstrations. There will be several tests throughout the nine days.

Registration expenses are estimated in the \$275 to \$400 range. Dormitory rooms costing \$13-\$15 per night for a shared room and \$20-\$22 for a single are available nearby. Other housing may be found in area hotels ranging from \$20-\$80.

First Alan Schneider Director Chosen

Mary B. Robinson has been named recipient of the first Alan Schneider Director Award.

The new award, given to pay tribute to the late Alan Schneider's unique contribution to the American theatre and his lifelong concern for the development of new generations of theatre artists, is the first to recognize American stage directors on a nationwide basis. The award is designed to assist mid-career directors who have exhibited unusual talent, have achieved local or regional reputations, and who merit national attention.

The honor carries a cash award of \$10,000 toward parital support of two directing opportunities with major professional theatres.

Robinson, who was selected from scores of candidates nominated by artistic directors of theatres nationwide, is the former associate artistic director of the Hartford Stage Company, where she directed Eugene O'Neill's Desire Under the Elms and Constance Congdon's No Mercy, among other plays. She has also directed at Cincinnati Playhouse in the Park, the Second Stage and Playwrights Horizons in New York, and Actors Theatre of Louisville. As the first Alan Schneider Director, Robinson will undertake directing assignments in the coming season at the Milwaukee Repertory Theater and the Seattle Repertory Theatre.

IES 1987 Design Awards

Winners of the 1987 International Illuminating Design Awards, the most prestigious awards granted in the lighting design field, were announced May 15 in New York City by the awards program's sponsor, the Illuminating Engineering Society (IES). Presentations were made to eleven winners of the Edwin F. Guth Memorial Award of Excellence and three winners of the Guth Award of Special Citation at the IES Annual Conference in Scottsdale, AZ, August 5.

The IES initiated the IIDA program to publicly recognize professionalism, ingenuity, and orginality of lighting design based upon the individual merit of each entry judged against specific criteria.

Architectural Models At Queens Museum

New New York, an exhibition of some 50 rare architectural models of important New York City structures, will be on view at The Queens Museum from Aug. 1 to Oct. 4. The exhibition will illustrate recent trends in architecture and explore the sometimes volatile issues inherent in New York City development. Besides models of individual buildings, New New York will feature before-and-after photos of specific sites, context models of entire city blocks, and composite photos, in which models are montaged against realistic background images.

New New York will provide a rare opportunity to review a cross-section of contemporary architectural styles. Significant structures in each borough will be featured, including projects by Edward Larrabee Barnes, Philip Johnson, Kohn Pederson Fox, I.M. Pei, Cesar Pelli, Kevin Roche, and Skidmore, Owings and Merrill.

Robert A.M. Stern, architect, teacher and authority on New York architecture, served as exhibition advisor and contributor to the 48-page catalogue.

ENDOWMENT FUND 1987-88 GUIDELINES SET

The United States Institute for Theatre Technology established an Endowment Fund in 1978 as a means to foster the goals and objectives of the Institute and have funds available to support the work of the Institute. Since its establishment, many individual and corporate members of the Institute have contributed funds to increase the corpus of the fund; this, along with judicious investment of the Endowment funds are allowing the announcement of awards to be made from the Endowment Fund.

The Endowment Fund is managed by a Committee of the USITT Board of Directors. All applications are reviewed by this committee, and the decisions on all awards are made by this committee. The Committee Members are: Donald C. Shulman, Chair; Richard Devin, Tim Kelly and Richard Arnold.

The following Statement of Purpose and Award Guidelines will give the needed information so that you will be able to apply for support for your programs.

STATEMENT OF PURPOSE

The Goal of the USITT Endowment Fund is to further and perpetuate the objectives of the Institute. Accomplishment of the goal will be achieved through the financial support of specific undertakings of Institute members. Only new projects and research with the expressed purpose of the advancement of the industry will be given consideration by the Trustees of the Endowment Fund. Grants awarded are intended for a complete project or as seed money for a given project, not as ongoing support.

GRANT AWARD(S)

The Committee will make one or more awards totalling no more than \$2,500.00. Projects requiring more than this level of funding will need to secure those additional funds from some source other than the USITT Endowment Fund or USITT Annual Operating Budget.

While there are no requirements for projects to provide matching funds, the Endowment Committee is desirous of making the most effective use of its available funds.

GRANT AWARD GUIDELINES

A. Who may apply for Endowment Fund Assistance? Any member of USITT is eligible to apply for assistance. Also eligible to apply are groups of members such as Sections, Student Chapters, Commissions, Committees, and groups of individual members.

B. How are Applications Filed?

All proposals must be sumitted directly to the Endowment Fund Committee, care of the Institute's National Office, on current application forms. Additional copies of the forms are available from the National Office. (330 West 42nd Street, Suite 1702, New York, NY 10036 (212) 563-5551).

C. Application Deadline

The deadline for this year shall be Oct. 31, 1987. Applications received after that date will not be reviewed by the Trustees. The starting date for projects receiving Endowment Fund Assistance shall be no earlier than Jan. 1, 1988 and the ending shall be no later than Dec. 31, 1988.

D. Award Criteria

In giving full and complete consideration to the applications that are received, the committee follows certain criteria in its review process. The critieria are: Ability to successfully implement proposed project Creativity Impact on USITT and Industry Innovation New Project

Relationship to Areas of Institute Involvement Sponsored by & Critically involving Insitute Members.

E. Areas Not Supported by Endowment Fund

Acivities for which Academic Credit is being sought Bad Debts

Capital Expenditures unrelated to a specific project Creation of New Organizations

Expense incurred before Starting Date of Grant Period

Investments of Any Kind

F. Award Letter

When an award is approved, a letter and/or contract is forwarded to the applicant specifying the terms of the award. After the applicant agrees to the terms, no major changes should occur either in activities, personnel, or budget, unless approved in writing, in advance by the Endowment Committee.

G. Reports.

A final narrative and financial report is required of all award recipients. Final reports are due within sixty (60) days after the end of the project period. The form for these reports will be supplied by the Endowment Committee to all award recipients.

H. Credit Line

All award recipients must include the following credit line in all advertising, news releases, reports, publications, and printed programs:

"The program/project/event (or other appropriate words) was made possible, in part, through a grant from the United States Institute for Theatre Technology Endowment Fund."

I. Application Forms

All applications for support from the USITT Endowment Fund shall be made on current application forms. All applicants should submit ONE Original and TWO Copies of each application filed. Should you need more space to answer any of the questions on the form, you may continue on another sheet of paper. Please be as concise with your responses as possible. Arts and Machines

Two major exhibitions opened August 16 at the Los Angeles County Museum of Art to provide visitors with a unique occasion to view the history of American design during the first half of the 20th century. Featuring sequential periods in American art yet both responding to the industrialized world, "The Art that is Life": The Arts and Crafts Movement in America, 1875-1920 and The Machine Age in America 1918-1941 have been scheduled at the Museum to be seen together, an event that is occuring nowhere else on the exhibitions' respective national tours. The issues raised in both of these exhibitions still capture design and aesthetic interest today.
