USITT Summer Meetings

Three Days of Institute Business Meetings held in Chicago



SITT concluded three intensive days of business meetings with a Board of Directors Meeting at Mundelein College in Chicago on 12 August 1990.

During the long weekend there were meetings of the Commissioners, the Finance Committee, the Priorities and Planning Committee, the Publications Committee, the PQ'91 Steering Committee, the Nominations Committee, the Membership Committee and the Executive Committee.

In addition to the tri-annual Board meeting, a major activity of the Summer meetings was the program planning session for the 1991 USITT Conference and Stage Expo to be held in Boston 20-23 February 1991. The Boston Conference promises to offer an exciting schedule of programs and activities.

The actions and activities of the August 1990 Board of Directors meeting included:

• Approval of a new membership category. The "Senior" membership class is "open to members who have been individual, joint or professional members of the Institute and who have retired from active work in the performing arts. Dues will be set at 80% of the individual rate..."

• Approval of the proposal for a Canadian Institute for Theatre Technology (CITT) and authorization of the President to make appointments and arrangements as necessary to facilitate the membership administation, publications distribution and other services as outlined in the proposal.

• Approval of a Board-designated fund to support special commission activities. The fund would be the excess of income less expenses of the commission sponsored pre- and post-conference workshops and events.

• Approval of a By-Laws change stipulating that "All officers shall be members in good standing of the Institute and a Regional Section."

• Approval of the slate for the 1991 Institute elections (see report on page 2).

• Approval of the 1990-91 USITT Budget.

The next Institute business meetings—the USITT Winter Meetings—will be held 15-17 November in Orlando, FL. ■

New Membership Cards have just arrived for the new season! The new cards will be mailed to all renewing and new members. USITT will be taking part in "A Day Without Art '90" which will be held on 1 December 1990. The national event—sponsored by Visual AIDS, a collective of visual arts professionals—gives artists an opportunity to make their constituencies aware of AIDS' effect on the arts community. The organizers hope this year's event will include the visual and the performing arts. Participating institutions are encouraged to

reach beyond their traditional constituencies and coordinate efforts involving people with AIDS, schools, homeless shelters and AIDS service organizations in order to promote discussion about the prevention and treatment of the HIV virus. Festival 2000 is a celebration of cultural diversity that will fill the streets, parks, community and arts facilities of San Francisco 6-28 October 1990. More than 1000 performers will present over 200 productions emphasizing multiculturalism. The festival is designed to celebrate the artistry of these performers, and to allow them to work creatively with traditions within, as well as outside, their own cultural communities.

1991 Nominations Slate

ith the publication of the nominated slate of USITT officers for 1991, it's appropriate to remind the members that, since the last election, a By-Laws amendment has established two changes to the process:

(1) The committee on nominations may now place more than one name in nomination for one or more office when they find that appropriately qualified and willing candidates have been identified, and,

(2) The committee shall present to the members a slate of 12 candidates to fill six member-atlarge positions.

As chair of nominations, I believe it is important to inform the membership that, although several additional members were solicited for inclusion on the nominated slate, the ballot includes only one name for each office. Although two nominees mentioned personal or professional reasons for declining, many of those contacted, though willing to serve, indicated that they felt the incumbent officer was doing excellent work and that they would not wish to challenge if the incumbent agreed to be placed in nomination.

Additional nominations for each elective office may be presented by petition, supported by no fewer than fifty (50) signatures verified as those of members in good standing in the Corporation. Additional nominations shall be accompanied by written approval of the nominee and a brief biographical description. Petitions must reach the Chair of Nominations, Richard Devin, Colorado Shakespeare Festival, Box 261, University of Colorado, Boulder, CO 80309-0261 by 1 November 1990.

Nominees for all offices and directorships shall have been Individual or Student members of the Institute or the individual designated as the voting representative of an Organizational, Sustaining or Contributing membership for at least one (1) year as of September 1 of the year of their nomination.

The President's Report

he new fiscal year is off to a fast start. The August Board Meeting has already come and gone, and because of the timing of the Board meetings this year—August, November and February—it appears as if everything will be on a "hypertrack."

The August Board meeting and Commissioners retreat was most productive. The officers, commissioners, committee chairs and Board members are all to be commended for the long hours they worked, both in preparation for the meeting, and for their endurance during that weekend.

A number of long-standing administrative projects were brought to completion at this meeting. Vice President for Relations Norm Bouchard released the newest edition of the *Section Officers' Handbook*. Dick Durst, Vice President for Conferences, unveiled the most recent revision of the USITT Conference Manual. Both of these documents have been in development for many months.

Also presented at this meeting was a new pamphlet created by Chris Kaiser with the assistance of Leon Brauner, Jean Montgomery and Sarah Nash Gates. This is a collection of financial policies and procedures as well as a concise description of the budget process. This is the first compilation of financial policies in written form in one place. Institute members who would like a copy should contact the National Office.

A parallel document outlining other adminis-

trative policies is now in preparation by USITT Secretary Jean Montgomery. The first draft of a USITT Board Manual and Policy Compendium was given to the Executive Committee for review during the meeting. Many thanks to Gino for taking the initiative in this area.

As you can see, the Institute is well on the way to having good documentation for its policies and procedures. Any members who have any questions about our programs or policies are urged to contact the appropriate officer or me.

In other reports in this issue of *Sightlines* you will read more about the ongoing work of the Institute. I know you will be interested in the new cooperation and initiatives between USITT and IATSE. Dick Durst met with the Stagchands Caucus during the recent IATSE Annual Meeting in Hollywood, FL. This meeting was the result of many prior meetings by Bill Flynn, National Liaison Chair, and Jared Saltzman, our liaison with IATSE.

A great deal of work during the USITT Summer meetings was directed at planning for the upcoming 1991 Conference and Stage Expo in Boston. Led by vice president for Commissions Leon Brauner, the commissioners and vice commissioners worked with the leaders of Boston Conference Committee, VP for Conferences Dick Durst and with Events Production Group, the Institute's Conference Management firm to plan much of the program for February's meeting in Boston. ■

IATSE Presentation

Richard Durst, USITT Vice President for Conferences

was very pleased to be able to represent Don Shulman and the Institute at the 60th biennial convention of the International Alliance of Theatrical Stage Employees (IATSE) in Hollywood, Florida on 24-25 July 1990.

I was asked to be one of the three speakers to the international delegates to the Stagehand Caucus on the theme of "Educate, Communicate and Organize." Judging from the response after the caucus, I believe the information about USITT and its programs was received very well.

IATSE has recently approached us with an interest in cooperative projects and International President Al DiTolla is sincerely concerned about "educating" and upgrading the union personnels' skill in new technology. I believe USITT can help with those goals.

The other two speakers, Jeremiah Harris (whose company built all the automation for the *Phantom of the Opera* and *Les Misérables*) and John Paul III (production manager for Cameron Mackintosh, producer of the above shows), both spoke of the need for highly trained workers on the tours of Mackintosh shows. The complexity of the scenery required special training that is beyond the scope of the traditional union member. They urged both the union officials and delegates to encourage this education of IATSE workers or the companies would be forced to hire non-union labor. Their focus fit nicely with my presentation on the programs that USITT sponsors. After the meeting I handed out all the membership brochures that the USITT National Office had and could have used twice that many.

IATSE has requested permission to publish my presentation in its international *Bulletin* and John Petrafesa, assistant to the IATSE president, said they were very interested in publishing information about USITT in the *Bulletin* as well.

I think this is a marvelous opportunity to make a big push for cooperation within the two organizations. I would hope that those of you who are or know IATSE members spread the word to others in the International Alliance. We can be of great service to them as well as tapping their knowledge. I was made to feel very welcome and appreciated the opportunity to represent USITT to this organization.

Sound Commission

chool's started and that always makes me feel that it's time to say, "Welcome back." Yes, I know I'm saying just what I said last year at about the same time. I realize that I may be the one who's been gone, having taken a somewhat unintended break from writing for Sightlines. One way or another, however, most of us, commercial as well as educational theatre people, are set to start into a new season.

As I'm sure a number of you will remember, a small storm blew up last Spring about USITT's service to professionals. One mission of USITT, possibly its most important service, is to facilitate the dissemination and exchange of information. But information for whom, exchanged among what venues? One of the complaints voiced last Spring centers around information and services that seem primarily intended for the educational sector.

Educators are always in the business of information exchange, of course. We need information to pass on to our students. But we're not alone. Professional designers and technicians are in need of information to keep working resources current. From whom do we get our information? What sources generate the information that USITT should make available to all of us?

An advanced theatre technology can only be driven, it seems, by profit. Commercial theatre and that includes the concert industry, industrials, and the like—must reach for novel effects, because without those effects audience and revenue will go elsewhere. Achievement of an effect is a matter of application, but when an effect is needed over and over again, with no convenient way to achieve it, then the matter transcends the individual application. Real problems are defined by difficulties that recur with some frequency. To those problems entrepreneurs, and their engineers address themselves. Who provides the information needed to address the real problems?

Sound is probably one of the best bell weathers of the dilemma. Audio is a daughter of electronics which, in turn, is a daughter of the physical sciences. The pure research that brought about silicon chips and wireless technology is far removed from our momentary applications.

If we have an information gap in theatre technology, I suggest that it lies here—in the fact that no publication in theatre has a consistent practice of reporting developments in research in the parent areas that underlie all of our technical resources. Educators, professional designers and technicians, engineers and entrepreneurs are all potentially interested in such information. Here, potentially, is a niche that USITT could fill as part of its mission of information dissemination.

If we have a lack in fundamental research reporting, I certainly don't mean to suggest that the fault lies with USITT's editorial staff. The Institute's journal can only publish what someone will write for them. A project as large as basic information research requires a lot of time and effort. I suggest that the commissions need to take on this challenge. Right now, I'd say that only the Costume Commission is anywhere near meeting the need.

So far as sound is concerned, the upcoming Boston conference presents us with a unique opportunity. Boston is a rich resource in audio technology and in applications research. Sound Commission programming will attempt to make use of as many of those riches as possible. I'd like to propose that we also use the impetus of the conference as the start of an information bank for the theatre and entertainment audio industry, which includes all of us who make up the various aspects of USITT sound interests. The commissioner alone cannot make any proposal take shape, of course. If you find the suggestion worthwhile, I encourage you to help out. As noted, information research is a labor and time intensive effort. To begin with, I need sound interest people-in the Boston area especially. So if this appeals to you, get in touch with me. The next Theatre Technology Exhibit is scheduled for the 1991 USITT Conference in Boston (20-23 February 1991). The success of the previous two exhibits has prompted the Institute to make this a regular biennial event.

The objective of the Exhibit is to recognize and display the work of practicing theatre technicians in all areas: scenery, props, electrics, costumes, sound and painting.

The Exhibit is your opportunity to share your successes and help all of us avoid reinventing the wheel. Don't delay-fill out the entry form today!

RULES AND REGULATIONS

Each exhibit should focus on one of three categories:

- 1. Device—a demonstration of theatrical ingenuity or engineering.
- 2. Material—a description of how to use a new material to solve a common problem, or a familiar material used in a new application.
- 3. Process—a procedure used to solve a technical problem.

Entry forms must be accompanied by a one- to five-page paper, including drawings, photos, etc. The papers for those exhibits selected for presentation in Boston will be assembled in a catalog and made available to those viewing the exhibit.

The space set aside for each exhibit includes bulletin board area and table space (see "Display Options" on the Entry Form). Exhibits may include drawings, photos, data sheets, actual devices of models, samples of finished products and the like.

The entry fee is \$25. Make your check payable to USITT.

Six prizes of \$300 each will be offered. An Awards Committee will review the Exhibit in Boston. Prize recipients will be announced at the Convention.

USITT ENDOWMENT FUND

The United States Institute for Theatre Technology established an Endowment Fund in 1978 as a means to foster the goals and objectives of the Institute and have funds available to support the work of the Institute. Since its establishment, many individuals and corporate members of the Institute have contributed funds to increase the corpus of the fund; this, along with judicious investment of the Endowment, are allowing the announcement of awards to be made from the Endowment Fund.

The Endowment Fund is managed by a committee of the USITT Board of Directors. All applications are reviewed by this committee and decisions on all awards are made by this committee. The committee members are: Tim Kelly, Chair; Richard Devin, Donald C. Shulman, Richard Arnold, Randy Earle and Sylvia Hillyard.

The following "Statement of Purpose and Award Guidelines" will give the needed information so that you will be able to apply for support for your programs.

STATEMENT OF PURPOSE

The goal of the USITT Endowment Fund is to further and perpetuate the objectives of the Institute. Accomplishment of this goal will be achieved through the financial support of specific undertakings of Institute members. Only new projects and research with the expressed purpose of the advancement of the industry will be given consideration by the Trustees of the Endowment Fund. Grants awarded are intended for the complete project or as seed money for a given project, not as ongoing support.

GRANT AWARD(S)

The committee will make one or more awards totaling approximately \$5,000. Projects requiring more than this level of funding will need to secure those additional funds from some source other than the USITT Endowment Fund or the USITT annual operating budget.

While there are no requirements for projects to provide matching funds, the Endowment Committee is desirous of making the most effective use of its available funds.

GRANT AWARD GUIDELINES

A. Projects Supported by the Endowment Fund

To receive consideration for an Endowment Fund award, a proposal must:

- (1) Establish that it clearly seeks new knowledge through experimentation, research or collection of resources for research or study purposes. Projects which only perpetuate available existing information will not be considered.
- (2) Primarily benefit members and interest areas of USITT and advance the industry in general, directly relate to the goals and purposes of the Institute, serve a cross section of the Institute, and not be merely a parochial benefit to a limited region, group, organization or individual.
- (3) Provide results which are made available to Institute members through direct presentation/demonstration, publication or visitation.

B. Award Criteria

In giving full and complete consideration to the applications that are received, the committee follows certain criteria in its review process.

- The criteria are:
- Ability to successfully implement the proposed project
- Creativity and innovation
- Impact on USITT and the industry
- New project
- Relationship to areas of Institute involvement
- Sponsored by and critically involving Institute members
- C. Areas Not Supported by the Endowment Fund • Activities for which academic credit is being sought
 - Scholarships or tuition
 - Bad debts
 - Investments of any kind
 - Capital expenditures unrelated to a specific project
 - Creation of new organizations
 - Expense incurred before starting date of grant period
 - Projects whose ending date extends beyond the closing date of period
 - Receptions and refreshments

D. Eligibility

Any member of USITT is eligible to apply for assistance. Also eligible to apply are groups of members, such as sections, student chapters, commissions, committees and groups of individual members.

E. Filing Applications

All proposals must be submitted directly to the Endowment Fund Committee in care of the USITT National Office using current application forms. Additional copies of the forms are available from the National Office (10 West 19th Street, Suite 5A, New York, NY 10011-4206; 212-924-9088).

F. Application Deadline

The deadline for this year shall be 31 October 1990. Applications **received** after that date will not be reviewed by the Trustees. The starting date for projects receiving Endowment Fund assistance shall be no earlier than 1 January 1991 and the ending date shall be no later than 31 December 1991.

G. Award Letter

When an award is approved, a letter and/or contract is forwarded to the applicant specifying the terms of the award. After the applicant agrees to the terms, no major changes should occur either in activities, personnel or budget unless approved in writing in advance by the Endowment Committee.

H. Reports

A final narrative and financial report is required of all award recipients. Final reports are due within sixty (60) days after the end of the project period. The form for these reports will be supplied by the Endowment Committee to all award recipients.

I. Credit Line

All award recipients must include the following credit line in all advertising, news releases, reports, publications, and printed programs:

Section Showcase: Alberta

Normand Bouchard, USITT Vice President for Relations

We are pleased to begin a new periodic feature in Sightlines—Section Showcase—where we will be recognizing the important contributions and activities of one of the key components of USITT, the regional sections. We encourage all members of the Institute to be active participants in their local section. —Ed.

SITT's Alberta Section wasincorporated in Alberta in the spring of 1980 as "the professional guild of artists and craftpersons" to "provide research, publications, exhibitions, networking and representation for persons working in the live theatrical production industry."

Toward that end the Alberta Section has, in the past ten years, hosted or supported more than 45

seminars, workshops, and conferences, and has published or distributed a number of informational documents, including a regular newsletter.

Our current membership includes more than 250 persons, mostly Alberta residents, from a wide variety of employment and theatre disciplines, including professionals, amateurs, educators, technicians, designers and administrators comprising individuals or organizations from both urban and rural environments. Possibly one of the most

exciting and successful activities undertaken in 1985 was the launch of the Alberta Section's "CallBoard" project. There are now more than 160 registered users of CallBoard, from Victoria to Newfoundland, and our services include electronic mail, bulletin boards and on-line, disk or hard-copy databases. The "Organizations" database is a listing of theatre and related arts organizations in Alberta, and the "Suppliers" directory is a listing of performing arts suppliers in Canada and the United States. We have recently received two financial assistance grants from USITT to further expand this project.

The 1989 USITT Annual Conference and Stage Expo was hosted by the Alberta Section 12-15 April 1989 in Calgary, and marks a sort of "achievement plateau" for the Section as one of the most successful conferences that the Institute has ever held. More than 2500 persons attended, including nearly 100 from overseas. The trade show, Stage Expo '89, was sold out, and the conference attracted a significant proportion of new Canadian exhibitors and delegates.

It is an understatement to say that the conference's success was due in no small part to the outstanding service, dedication and efficiency of the members of the 1989 Conference Committee. As well, many other members of the Alberta

Section worked as volunteers, and may feel proud of their efforts. This conference culminated seven years of planning and significantly raised the profile of the Section and of theatre technicians and designers in the performing arts industry in Canada. It will have a long-lasting and positive impact on the Canadian performing arts community.

The Alberta Section is just completing the fifth year of its joint program with the Alberta Culture and Multiculturalism in the Community Theatres Workshop program which provides workshops in various aspects of technical theatre throughout Alberta. Originally targeted to provide 10 to 15 workshops in its first year of operation, the program has now presented more

than150 technical workshops throughout Alberta in a wide variety of subject areas.

In 1990, the Alberta Section has concentrated on the development of programs and services resulting from the 1989 USITT Annual Conference. In particular, the following activities have been the Section's focus:

(1) Technician Training and Certification: Sessions at the 1989 Conference concentrated on the current skills and competence of theatre technicians in the province and on ways to maintain or improve

on these standards. These discussions were continued at a subsequent conference of performing arts groups in Alberta in October 1990, and at the Alberta Section's 11th Annual Conference in Edmonton. At this latter event, a new committee was formed to consider ways to facilitate the development of an overall training standard for theatre technicians in Alberta.

(2) Pyro-Safety Standards: Again, as an outgrowth of activities in 1988 and 1989, the Alberta Section's Pyro-Safety committee has been working with Alberta Occupational Health and Safety to develop new standards for the use of pyrotechnics in performing arts activities. Most recently, following the 11th Annual Conference, the Pyro-Committee met for two days in Banff, Alberta to produce the first draft of an Alberta Standard. During 1990-91, this standard will be circulated throughout Alberta for comment and revision towards adoption in 1991. This committee is leading the way in Canada in this area.

(3) CSA Standards Committee: Four members of the Alberta Section flew to Toronto in September 1989 to meet under the umbrella of the Canadian Standards Association in formulating a new construction standard for lighting instruments and fixtures. This standard is now before the Technical Committee of the CSA. \blacksquare

he Costume Commission is pleased to announce that the Institute will select a qualified student to receive the annual scholarship provided by The National Costumers Association. The \$1500 award will be given to an outstanding student already making progress towards a graduate degree in costuming.

Eligibility—The student must already be participating in a graduate program in costume design and/or technology, with at least one additional year to go. Progress toward an MA or MFA must be demonstrated by portfolio and recommendation. The award will be made on merit; other forms of scholarship or support will not hamper a candidate's eligibility. The candidate must be a student member of USITT, national or regional chapter.

Award—A \$1500 non-renewable scholarship, to be applied toward tuition; in cases where tuition is fully paid by the institution, the award will be made to the student in the form of a taxfree grant.

Recommendations—Three recommendations are required, one of which is to come from the candidate's graduate advisor. Of the remaining two, one must be from the graduate faculty in which the student is enrolled. The other may be from an outside source, including design faculty from the candidate's undergraduate program or employer in the profession.

Deadline—Portfolio and letters of recommendation must be received by 14 December 1990. (We realize that this limits first-year students, but the February USITT Conference and ACTF conflicts necessitate.)
